How your support helped Fusiliers in 2016

What we do.

The Fusiliers Aid Society (FAS) is the benevolent fund of The Royal Regiment of Fusiliers. It has incorporated the benevolent funds of our antecedent Regiments namely the Royal Northumberland Fusiliers, The Royal Warwickshire Fusiliers, The Royal Fusiliers and the Lancashire Fusiliers. The fund supports all Fusiliers, regardless of rank, serving and retired, and their widows and dependants when there is evidence of hardship and need.

We also distribute Christmas grants to some veterans, widows, families and children, as well as ensure that the welfare funds of the First Fusiliers and our Reserve units are funded. This enables the welfare officers and Commanding Officers to provide welfare support to those under their command.

The fund can also make grants to support commemorative events, enabling the bereaved families and veterans to attend if they so wish.

2016 at a Glance

- 133 individual cases
- Over £133,000 distributed for the benefit of individuals
- £8,000 distributed to Battalion welfare funds
- £37,000 distributed to relevant service charities
- £8,570 distributed to veterans, widows and families as Christmas grants
- £61,000 distributed to serving and former members of the Regiment by the ABF Soldiers Charity.

FAS works closely with other service charities, notably SSAFA, The Royal British Legion, the Army Benevolent Fund and Help For Heroes to ensure applicants' needs are met.


Our income is derived from investments, donations and the One Day's Pay Scheme (every soldier in the Regiment donates a days' pay to the fund - the scheme is administered by the MoD).

Donations are also key, as is active fundraising by those able to do it.

FAS maintains a page on Justgiving.com (www.justgiving/fusiliersaidsociety.com) which is used by individuals undertaking sponsored events.

Sources of Funds 2016

- £197,000 investment income
- £38,000 from donations
- £28,000 from One Days' Pay Scheme
- £2,200 from sponsored activities






How we help those in need.

The majority of our casework is conducted by SSAFA or RBL. However, cases can also be submitted by a Unit Welfare Officer, or the chain of command. Occasionally other agencies, such as The Officers Association or Veterans Aid submit cases to us.


Once cases have been considered, any resulting grant is administered by the caseworking organisation. Grants are only paid to individuals in exceptional circumstances.

We have seen many requests for help to cover funeral costs for relatives, but FAS is not permitted under its objects to contribute to funeral expenses. Where suitable, and if there is evidence of hardship, FAS may make a discretionary general needs grant.

As central government attempts to cut its welfare budget, as well as its funding to Councils, forces related charities are seeing increased demand for funding that would otherwise have been provided centrally.



Ex Fusilier - 39. He had to move house after he separated from his partner. FAS granted £870 to help with furnishing his new accommodation.

FAS is often asked to provide white goods (washing machines, fridges, cookers etc.) and brown goods (carpets, curtains, furniture etc.) to applicants. Marital (and cohabitation) breakdown mean that we see single households become two, with all the complications that can bring. Often there are children involved.

Working with other Charities.

FAS works in conjunction with other service charities to deliver benevolence. SSAFA and RBL do the bulk of our casework, but where an applicant's needs are more complex or expensive, The Army Benevolent Fund (ABF) can be approached for assistance, support and advice.

In 2016, The ABF granted in excess of £61,000 to 77 cases. Often, these grants are in addition to a FAS grant, and occasionally, the ABF will help where FAS is unable to. Close liaison ensures that needs are met where possible. FAS makes an annual grant to the ABF (2016 - £17,000) to help them help our veterans.

Ex Fusilier - age 41. FAS granted £950 to help furnish a flat.

Ex Fusilier - age 44. Granted £300 to buy special bike for 10 year old with cerebral palsy.

In brief:

- £1000 to ex widow of KIA
 Fusilier enabling a family visit
 to take place. ABF also
 supported with £1000.
- £1080 to ex Fusilier (aged 92) for top up fees for his care home.
- £500 to ex Fusilier for travel and accommodation for PTSD course.
- £2000 to serving Fusilier for travel and accommodation to his home country following the unexpected death of a brother.
- £1500 to ex Fusilier for accommodation whilst attending a career course.
- £950 to ex Fusilier to enable him to regain his HGV licence.
- £500 to recently discharged Fusilier for training course.

Serving Fusilier - age 23. Granted £813 for flight from Canada (where Battalion was on exercise) to UK for Grandmothers funeral.

Thank you so much for paying for my flight to my Nan's funeral. As the MoD wouldn't pay, and I couldn't afford it, it was a huge comfort for me to be able to be there to say goodbye.

FAS also makes annual grants to organisations directly supporting our 'family'. In 2016, a grant was made to Northumbria ACF to enable a party of research the cadets to **EOKA** campaign (in which the Regiment was involved) whilst on annual camp in Cyprus, and enable them to study the campaign and pay their respects to the fallen. Cpl J Warren age 25 and Sqt F Coleman age 40, both from the Royal Warwickshire Regiment, were killed in action in May 1956.

Ex Fusilier - age 62. Granted £600 to enable him to go bankrupt.

My wife and I would like to thank you for all the help you at the Royal Regiment of Fusiliers gave to us when we were in desperate need for help to proceed with bankruptcy.

I did not know when I joined the army all those years ago, that the Fusiliers would come to help me and my family all those years later with the cost of our bankruptcy, we do not know any way to thank the Royal Regiment of Fusiliers for all the help they have given to me and my family.
